

Terms and Conditions of Non-Monetary Prize of game edition “Splash in Winnings”

1. Description of the prize

- 1.1. Société anonyme under name “Hellenic Lotteries S.A.”, having its seat in Athens (112 Athinon Ave.), TIN 800500383, Athens Taxation of Commercial S.A. Companies Office, hereinafter the “Company”, places “Splash in Winnings”, of €2 value, on the Greek market as of 15 May 2019. In accordance with article 3 of the Special Regulation on Instant State Lottery, the lottery ticket, apart from monetary prizes, also offers non-monetary prizes, hereinafter called “NMPs”.
- 1.2. The NMPs appear in the playing area of the lottery ticket, in the same way monetary prizes do. Therefore, in accordance with the instructions mentioned on the front side of the ticket, the player scratches the ticket and if he/she finds the “Splash” symbol, he/she wins the NMP.
- 1.3. In accordance with the distribution system of the edition, there is a winnings category that offers NMPs. In particular:
 - 1.3.1. Type: Holiday package in Cyclades of gross value of €7,041 (the net value of the prize, following the deduction of the winnings tax, is €5,999.85)
 - 1.3.2. NMPs number: 10

More information on the exact description of the NMPs is mentioned in paragraph 3 of the present document.

- 1.4. In case the winner cannot accept the said NMP, he/she may choose, if he/she wants, to receive the monetary value of the NMP, €7,041 (the net value of the prize, following the deduction of the winnings tax, is €5,999.85). Cases are indicatively mentioned below, in which the player may opt for the receipt of the monetary value of the NMP.
 - It is not possible for the winner to travel by plane.
 - The winner does not want to visit the predefined destination (Cyclades).
 - The winner cannot travel due to temporary or permanent disability.

2. Redemption process

- 2.1. The player may redeem the NMP only at the Company’s offices in Athens and Thessaloniki, and only following communication by phone (upon appointment).
- 2.2. The player sets the appointment by contacting the Company’s call center at 800-800-5000 or by mobile phone at 2105798500.
- 2.3. Upon the redemption process, if the player chooses to receive the NMP, he/she gets the receipt of payment of the NMP and then he/she contacts the travel agency, which the Company has chosen, for the details of the trip. The cooperating travel agency is GS TRAVEL (25 Filellinon St., 10557 Athens, tel. 210 37 16 315).
- 2.4. In case the player chooses to receive the monetary amount of the NMP, then a payment order is issued for the bank.

3. Terms of the trip

- 3.1. Each trip (holiday package) on an island of Cyclades includes the following and is of a total value (following the deduction of the winnings tax) of €5,999.85, including VAT.
 - Economy class airline tickets with baggage
 - Airport taxes

- 5 overnight stays in a double room, at a 5-star hotel, breakfast included
 - Transportation from the airport to the hotel and vice versa
 - Civil liability insurance
- 3.2. The player may choose the island of his/her choice from the Cyclades group of islands and only from the destinations defined by the cooperating travel agency GS TRAVEL.
- 3.3. Any adjustment to the type of room or to the number of overnight stays is possible, as long as the total value does not exceed the value of the NMP.
- 3.4. The budget of this specific trip can be used by the winner and by one or more persons of his/her choice, as accompanying persons, as long as the total amount does not exceed the value of the NMP.
- 3.5. Any adjustment to the type of room or to the number of overnight stays is possible, as long as the total value does not exceed the value of the NMP.
- 3.6. The NMP can be used at any period based on availability and, in any case, up to 6 months following the expiry of this particular edition of game **“Splash in Winnings”**.
- 3.7. There is no choice offered for partial use of the NMP (in two different periods).
- 3.8. For the winner's optimum service, the Company recommends that the player should arrange the details of his/her trip at least 2 months prior to the preferred date, so that relevant availability can be guaranteed within budget.
- 3.9. The NMP is personal and it cannot be exchanged, nor can its replacement with another prize be requested, unless the player asks for the payment of the monetary value of the NMP, as mentioned above.
- 3.10. The terms on the processing of the player's personal data are included in the “Information on the Personal Data Protection of Winners of the Non-Monetary Prize of game edition ‘Splash in Winnings’”. Provided that the player gives his/her written consent, the Company holds the right to announce the names and to publish the photos of the winners on OPAP's Instagram (<https://www.instagram.com/instaopap/>) and Facebook account (<https://www.facebook.com/OPAPsocial/>), on the Organization's digital assets, on any printed material thereof or via the mass media (indicatively, TV, radio, Internet and social media, press), and to proceed to the advertising promotion and exploitation of any relevant event, such as the attribution of the prize.

4. Obligations of the Company

- 4.1. The Organizer's liability shall be solely and exclusively limited to the provision of the planned Prize.
- 4.2. In case the cooperating travel agency ceases its operation for any reason, the Company is obliged to offer the same services and the value of the NMP to the winner through a new travel agency of the Company's choice.
